# GET A SWEDISH IDENTIFICATION NUMBER (SAMORDNINGSNUMMER)

When you start working in Sweden, then you must also pay income tax in Sweden. You must therefore register with the Swedish tax authorities, Skatteverket. You don't need to have a Swedish citizen registration number to work in Sweden, but you do need to have a Swedish identification number. You can get a Swedish identification number by applying for Swedish SINK tax with the Swedish tax authorities, Skatteverket using a form SKV 4350 "Special income tax for non-residents".

### SINK TAX OR TAXED ACCORDING TO NORMAL SWEDISH REGULATIONS?

If you live in Denmark and commute to Sweden for work, you must decide whether you would rather pay tax according to the Swedish SINK scheme (only 20 percent tax, but no opportunity for tax-free allowance or other deductions) or be subject to the same tax regulations that apply to Swedish citizens.



## REGISTER WITH THE SWEDISH SOCIAL INSURANCE AGENCY (FÖRSÄKRINGSKASSAN)

You should register with the Swedish Social Insurance Agency, Försäkringskassan, when you require a specific benefit, have children or for example need to order a EU-health insurance card.

### MOVE YOUR MEMBERSHIP OF AN UNEMPLOYMENT INSURANCE FUND OR UNION

When you live in Denmark and work in Sweden, then you must also take out unemployment insurance in Sweden. Register yourself with a Swedish unemployment insurance fund on your first working day in Sweden. If your unemployment insurance is based in the wrong country, you will be considered as unemployed. If you wish to join a trade union, you should also choose a Swedish one, as Danish unions have no influence on the Swedish labour market. If you are already a member of an unemployment insurance fund and union in Denmark, then you must transfer your membership to the Swedish counterparts.
